
Pride In Service

Alarm System Permitting Program





In 2016, the San Marino
Police Department reported
over 98% (over 2213 calls) of
burglary alarms were false
alarms. This prevents public
safety resources from
responding to true
emergencies. The City of San
Marino is continuously
working with its inhabitants
to reduce the number of false
alarm instances.

False Alarm Stats

Alarm systems operating within the city of San Marino are required to have a valid alarm permit issued by the San Marino Police Department. Newly installed alarm users should submit an alarm permit application as soon as possible. The user must provide the San Marino Police Department the address of the alarm location, address of the responsible party and the names/telephone numbers of two individuals that the Fire or Police Department may contact in the permit holder's absence.

Failure to Obtain an Alarm Permit

It is the sole responsibility of an alarm user to obtain an alarm permit prior to operating or maintaining an alarm system. If the Chief of Police becomes aware that an alarm user is operating or maintaining an alarm system without a permit, the chief of police shall provide written notice to the alarm user regarding the requirement that the alarm user obtain an alarm permit within thirty (30) days. Failure to obtain an alarm permit within this time frame shall constitute a violation of this article unless the alarm system is deactivated. (Ord. 0-10-1230, 5-28-2010)

Alarm Permit Fees

San Marino residents and business owners are to pay an annual permit fee of \$15. This fee should be payed when submitting an Alarm Permit Application and is due by January 31st of the application year. Payments can be submitted as listed below and may be made by check or money order made payable to the City of San Marino.
